From I-43, take exit #50 (WI-164/Waukesha/Big Bend)

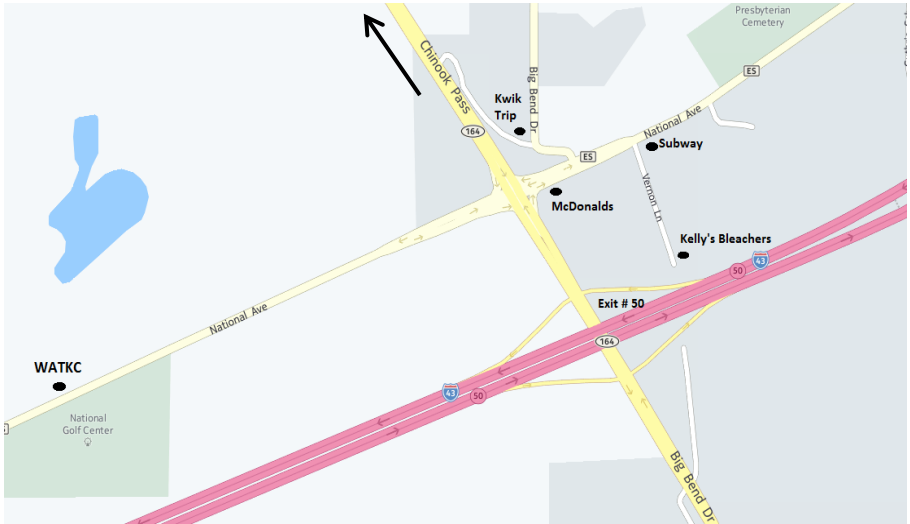
Turn towards Waukesha (northerly direction), go one block to stop light
